Politika zaštite ličnih podataka

Privredno društvo HBT LOGISTIKA doo je posvećeno zaštiti i poštovanju ličnih podataka i privatnosti svih fizičkih i pravnih lica

Ova politika objašnjava načine i razloge prikupljanja ličnih i drugih podataka kao i način i svrhu korišćenja prikupljenih ličnih podataka.

U pogledu ličnih podataka HBT LOGISTIKA doo kao rukovalac podacima, obrađivač ili korisnik ili subjekat koji na bilo koji način određuje svrhu i način na koji se obrađuju lični podaci, nastoji da prikupljanje ličnih podataka svede na najmanju moguću meru i to samo kada je to neophodno u svrhu izvršenja ugovora u kojem je lice na koje se podaci odnose ugovorna strana ili radi preduzimanja mera na zahtev lica na koje se podaci odnose pre zaključenja ugovora.

HBT LOGISTIKA doo kao rukovalac podacima, obrađivač ili korisnik ili subjekat koji na bilo koji način određuje svrhu i način na koji se obrađuju lični podaci, sve lične podatke prikuplja uz izričiti pristanak i saglasnost vlasnika ličnih podataka.

U pogledu ličnih podataka HBT LOGISTIKA doo rukovalac podacima, obrađivač ili korisnik ili subjekat koji na bilo koji način određuje svrhu i način na koji se obrađuju lični podaci, ističe da podatke prikuplja u određene, izričite i zakonite svrhe i dalje ih ne obrađuje na način koji nije u skladu s tim svrhama.

Prikupljanje ličnih podataka se vrši iz razloga neophodnosti obavljanja poslovanja, pre svega zaključivanja ugovora, marketinških potreba

Policy of personal data protection

The company HBT LOGISTIKA doo is committed to the protection and respect of the personal data and privacy of all natural and legal persons.

This policy explains the purposes and means for the gathering of personal and other data as well as the ways and purpose in which those gathered personal data are used.

Regarding the personal data, HBT LOGISTIKA doo, as the processor, as the controller or as the recipient of the personal data or as the subject which in any way determines the purpose and the manner in which personal data are being processed, aims to minimise the gathering of personal data and to do so only when it is necessary for the purpose of execution of the contract in which the person the data refer to, is the contractual party or for the purpose of taking measures at the request of the person the data refer to, before the conclusion of the contract.

HBT LOGISTIKA doo as the processor, as the controller or as the recipient of the personal data or as the subject which in any way determines the purpose and the manner in which personal data are being processed, gathers all personal data with the explicit consent and approval of the owner of personal data.

Regarding personal data, HBT LOGISTIKA doo as the processor, as the controller or as the recipient of the personal data or as the subject which in any way determines the purpose and the manner in which personal data are being processed, points out that those data are collected for the specific, explicit and legal purposes and that they are not being processed in any way that is not in accordance with those purposes.
